

**The Framework Agreement
between
Cracow University of Economics
and
University of Kragujevac, Serbia**

In accordance with the principles of traditional friendship between Polish and Serbian people, believing that a cooperation in the field of culture, science and education is cosmopolitan without recognizing the borders between people and states, but contributing to further mutual understanding, bringing people together and strengthening of friendly relations, the Cracow University of Economics, Poland and the University of Kragujevac, Serbia agree to pursue their co-operation by concluding the following Agreement for the period of 3 /three/ years. In order to obtain these goals, the two universities agree to realize the cooperation:

§ 1

1. Cracow University of Economics and University of Kragujevac agree to cooperate within the following areas:
 - 1.1 Students exchange,
 - 1.2 Faculties exchange,
 - 1.3 Exchange of scientific and didactic materials,
 - 1.4 Joint research projects,
 - 1.5 Cooperation within the framework of European Union and other institutions programmes.
2. Both Universities are committed to fostering joint projects in the field of education and research and are open to any form of the potential cooperation.

§ 2

The mutual exchange, specified in §1, shall be kept in equilibrium for the period of **two** years.

§ 3

The Home University or a visiting person shall cover all travel expenses to the Host University as well as the costs of internationally recognised health and accident insurance of the visiting persons.

§ 4

Each form of joint activities shall be based on a Working Programme, which will specify the range, forms and details concerning the financing with reference to § 3 of this agreement.

§ 5

In the case of semester studies, students exchange shall be realised at the university level. In the case of seminars, students exchange shall be realised at the level of Faculties or Departments.

§ 6

Scientific exchange shall be realised on the basis of cooperation of the Faculties or Departments.

§ 7

Each Working Programme must be signed by the persons responsible for its realisation (Deans, Heads of Departments, etc.) and it must be approved by the university authorities.

§ 8

The persons responsible for this agreement implementation are:

- on behalf of Cracow University of Economics:

Vice Rector for Research and International Cooperation

- on behalf of University of Kragujevac:

Dean of the Faculty of Economics from the University of Kragujevac

§ 9

The Office for International Relations from the Cracow University of Economics and Vice Dean for International Cooperation from the Faculty of Economics from the University of Kragujevac are responsible for coordination of all activities related to this agreement implementation.

§ 10

The agreement becomes in force in the day of signing by legal representatives of both Universities and will be valid for 3 years.

§ 11

The agreement is terminable by both parties with 2 months notice.

§ 12

This Agreement is prepared in 2 copies (one for each side) in English language version both with the same legal force.
